With reference to your application dated.....and subsequent correspondence with the school/inspection in this regard, I am directed to convey provisional approval for Middle Class Syllabus/Provisional/Composite Affiliation for Secondary School Examination of the Board w.e.f 1.4.97.....to 31.3.2000.....

The above sanction is subject to fulfilment of the following conditions :—


1. The School will follow the national syllabus for the middle classes.
2. The School will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
3. The grant for approval of syllabus of the Middle Classes does not in any way imply any obligation on the part of the Board to affiliate the Secondary classes. The approval of middle class syllabus is not extendable as the purpose is to affiliate the school as a secondary school and not as a middle school.
4. The approval will also be subject to the condition that the school will make a fresh application for provisional affiliation of the Secondary Classes (IX-X) to the Board on the prescribed form in accordance with Rules and Conditions for Provisional Affiliation when class VIII has been started.
5. The school shall appoint only qualified and eligible staff.
6. The School will help the Board in the smooth conduct of the examination by placing the necessary accommodation i.e. Halls, Rooms available in the school premises and furniture at its disposal for holding its examinations free of charge, if required to do so.
7. The school will spare sufficient teachers for invigilation purpose at the examinations of the Board as may be required by the Board.
8. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required to do so.
9. The school will provide Laboratories, Library and other facilities as per norms of the Board.

10. The school will abide by the conditions of affiliation already prescribed or may be prescribed by the Board from time to time.
11. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
12. Service conditions, pay and Allowances and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
13. The school and its records shall be opened for inspection by an official of the Board or an authorised representative of the Board/State Education Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
14. The rate of tuition fees and other fees charged should be commensurate with the facilities provided.
15. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
16. No unrecognised classes shall run within the premises of the school or outside in the same name of school.
17. The school will not sponsor candidates for Board's examination of any other school/Branch which is not affiliated to the Board.
18. The school will create Reserve Fund as per the requirement of the Affiliation Bye-Laws/Rules of the Directorate of Education Delhi in the joint names.
19. The school should not start Class VIII/IX/XI without written approval of the Board. The Board shall not be responsible for any consequences in case Class VIII/IX/XI is started without following the affiliation bye-laws and obtaining the prior approval of the Board.

1. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
4. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

6. It will remit Annual Fee of Rs. 1500/- regularly.
7. The school should apply for further Extension of Provisional Affiliation before 30<sup>th</sup> June of the preceding year before the expiry of the date of Affiliation 'On Line' through CBSE Website [www.cbseaff.nic.in](http://www.cbseaff.nic.in) or [www.cbse.nic.in](http://www.cbse.nic.in) and send a copy of its confirmation page with prescribed fee of Rs.12,500/- in the shape of Bank Draft drawn in favour of Secretary, CBSE, Delhi.
8. **The school will be eligible to open CBSE pattern class XI from 01.04.2007. Accordingly, 1st batch of class XII of the school will be appearing at the CBSE Examination to be held in 2009.**
9. Other conditions are as per Annexure 'A' enclosed.

**SPECIAL CONDITIONS/DEFICIENCIES**

- 1) Appointment of professionally qualified PGTs for the subjects in which the upgradation to +2 stage has been accorded be made and their particulars be sent. (3)
- 2) The school is required to appoint professionally qualified teachers on regular basis. Position with regard to untrained teachers and teachers working on adhoc basis may be clarified.
- 3) Labs are required to be updated as per the requirements for +2 classes.
- 4) Library should keep growing every year.
- 5) Salary and other allowances are required to be paid to the staff of the school at least at par with the corresponding categories of the staff of the State Govt.
- 6) The result of the teachers undergoing B.Ed training be sent in due course of time.
- 7) The School Managing Committee is required to be constituted according to the provisions contained in the Affiliation Bye-Laws of the Board. After doing the needful in the matter, a copy of the same may be submitted. (1)
